WHAT ARE THE MAIN BENEFITS?

A gift in your will or trust is one of the most popular ways to provide long-term support of our mission, in large part to how simple these gifts are to set up. Here are two other benefits:

1. You can change your mind at any time.

A gift in your will or trust is made after you are gone, giving you the opportunity to update or amend it at any time in your lifetime. Plus because you are not actually giving the gift today, you don't need to worry that you will not have enough to live on in the future if your circumstances change.

2. You have options. You can choose to make a gift of a specific amount, but that's not the only option. Most of us don't know the size of our estate, so making a gift of a percentage is a perfect option.

Can I direct my gift to a specific program or area?

First, decide how much you would like to give and what to give—you can fund a gift with cash, securities, property, and other assets. Then, share Mt. Ascutney Hospital and Health Center's sample language with your estate attorney to create the gift.
